Meeting Minutes (Videoconference) November 20, 2021 9:00 am

Call to Order: The meeting was called to order at 9:04 am by chair James Demetriades (JD).

Approval of the Agenda: JF moved that the agenda be accepted; DS seconded. All in favor; motion passed.

Approval of Temporary Secretary: JF moved that JB be approved as temporary secretary for this meeting; DL seconded. All in favor; motion passed.

- 2. Collaborations with other nonprofits: Dec. 4, 4-8 (Rain date Dec. 11). CCD is providing a wreath for the Historical Society's outdoor event held at 395 Main St., Stevens-Frisbie House. DB is spearheading the wreath making.
 - a. CCD promotes the work of other nonprofits, so hope is that all members will promote and attend this activity.

- CT Dept. of Economic and Community Development; Art and Creativity; Funding Opportunities. Artists Respond - Currently accepting applications for Round 2. https://portal.ct.gov/DECD/Content/Arts-and Culture/Funding Opportunities/Artists-Respond
 - a. The Artists Respond grant program provides direct funding to Connecticut artists to pursue community-based projects that use the arts to respond to social issues, current events, and community needs.
 - b. Connecticut Artists may apply for a grant of either \$2500 or \$5000 to support artist fees and other project-related expenses. Projects must occur in Connecticut and be artist-centered initiatives that use the arts to inspire, empower, educate, and transform our Connecticut communities. CCD cannot apply. Only individual artists may apply. The wings project or Paint by Number might be applied for by individuals. Or other ideas possible.
- 4. Invitation extended to Open Studio Holiday Shopping Event, featuring the work of mixed media artist, Jean Rill-Alberto; Dec. 4, 10-4 at Ann Grasso's residence: 70 Strand Circle, Cromwell. Jewelry, glass paperweights, holiday cards, calendars, trinket boxes, sachet pillows, and more.
